Michigan State Representative John Pappageorge recently told fellow Republicans, "If we do not suppress the Detroit vote, we're going to have a tough time in this election cycle."

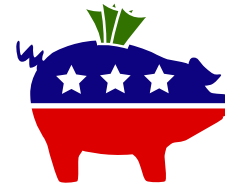
